Organizations defending the human rights of lesbian, gay, bisexual and transgender (LGBT) people in Ecuador continue to receive death threats.

Throughout April, Director of *Equidad* Orlando Montoya received several death threats. E-mails addressed to him accused him of being an "ideologist of human scum" and promised that he would "be the first" (Orlando Montoya mentalizador de la escoria humana seras el primero). Orlando Montoya is a well know human rights defender and was a co-founder of the first LGBT organisation in Ecuador, *Sociedad Gay*, Gay society. He has been advocating LGBT people's rights detentions without charge and police raids since 1985.

Amigos por la Vida, Friends for Life, has received at least five telephone threats in the last two weeks. A anonymous male caller said "we are keeping an eye on you" (los estamos vigilando).

On 30 April 2001, a number of Ecuadorean human rights organizations from Quito and Guayaquil presented a letter to the authorities informing them of the death threats that lesbian, gay, bisexual and transgendered people and defenders of their rights have been receiving since March. They expressed concern that the threats could be a sign of a wider homophobic movement like the one that took hold of the country in 1993 and 1994. At that time, more than 20 LGBT people were killed in individual attack. They also asked the Attorney General to take action to find those responsible for the threats and bring them to justice.

A similar letter was sent to the Ecuadorean Ombudsman, asking him to publically condemn the threats. Another letter was sent to the Human Rights Congressional Commission, asking them to do everything in their power to support the investigation.

In a resolution adopted in June 1999, the General Assembly of the Organization of American States (OAS) stated its intention to implement the United Nations (UN) Declaration on the Right and Responsibility of Individuals, Groups and Organs of Society to Promote and Protect Universally Recognized Human Rights and Fundamental Freedoms. The resolution called on member states to provide "human Rights Defenders with the necessary guarantees and facilities to continue freely carrying out their work of promoting and protecting human rights", as

well as to adopt "the necessary steps to guarantee their life, liberty, and integrity".

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or your own language:

- expressing concern for the safety of all the people and organizations named above;
- asking the authorities to do everything necessary to protect them, so they can continue their legitimate activities in safety;
- calling for an immediate investigation into the alleged death threats;
- reminding the authorities of their duty to ensure that human rights violations are investigated and punished;
- urging the Ecuadorean government to adhere to its obligations regarding human rights defenders, as laid out in the UN Declaration on the Right and Responsibility of Individuals, Groups and Organs of Society to Promote and Protect Universally Recognized Human Rights and Fundamental Freedoms, and the OAS Human Rights Defenders in the Americas resolution [AG/RES. 1671 (XXIX-0/99)].
