GUATEMALA Thelma de Lam (f), Fiscal Especial para los Defensores de los Derechos Humanos, Special Prosecutor for Human Rights Defenders

Amnesty International is seriously concerned for the safety of Thelma de Lam, *Fiscal Especial para los Defensores de los Derechos Humanos*, Special Prosecutor for Human Rights Defenders, who has reportedly been followed and intimidated. Concerns are heightened by the fact that Ms. de Lam is pregnant and has been threatened in the past.

Thelma de Lam was followed by two men on a white Honda motorcycle in Guatemala City, at around 5:30 pm on 11 March. Her bodyguards stopped the two men, who identified themselves as being members of the Guatemalan Army and advised her to "leave things as they are" ("dejen las cosas como están"). Later the same day, at around 9pm, Thelma de Lam was followed in her car for over an hour by an olive green pick-up truck with dark windows and no licence plates.

Thelma de Lam is a Special Prosecutor for Human Rights Defenders at the Human Rights Office and is currently investigating what became known as "Black Thursday" and "Friday of Mourning", when on 24 and 25 July 2003, the presidential campaign in Guatemala City was rocked by political violence. Journalist Héctor Ramirez was killed during the disturbances and former Head of State, General Rios Montt and former President Alfonso Portillo have been implicated in his death. General Rios Montt has been placed under house arrest, whilst an international arrest warrant has been issued for former President Alfonso Portillo who fled the country in February 2004.

Amnesty International is concerned that Thelma de Lam is being threatened in order to stop her from continuing her investigations. There are also concerns at reports that due to lack of funds, the Public Ministry has reduced security measures and resources for the Special Prosecutor's Human Rights Defenders Office, as this may have serious consequences for the security of those who work there and may also restrict their capacity to carry out investigations in cases of abuses against human rights defenders.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish, English or your own language:

- calling on the authorities to guarantee the safety of Thelma de Lam, *Fiscal Especial para los Defensores de los Derechos Humanos*, Special Prosecutor for the Human Rights Defenders;
- -calling the authorities to carry out an immediate, exhaustive and impartial investigation into reports of intimidation against Thelma de Lam on 11 March 2004, and to make the results public;
- -expressing concern at reports that security measures and resources of the Special Prosecutor's Human Rights Defenders Office, have been reduced which may have serious consequences for the security of those who work there and for their capacity to carry out investigations in cases of abuses against human rights defenders.
