GUYANA Ayube Khan
Rockcliffe Ross

Amnesty International has learned with deep regret that Ayube Kahn was hanged on the morning of 12 February 1996 in the first execution to be carried out in Guyana since 1990.

Rockcliffe Ross, who was scheduled to be hanged at the same time as Ayube Khan, was granted a stay of execution on 9 February, pending the outcome of a constitutional appeal to be heard at the high court later this week.

It was reported that no lawyer could be found to file for a stay of execution for Ayube Khan, despite the fact that a high court judge indicated he would be prepared to hear a motion for a stay. The lawyer who represented Khan at his last trial could not be contacted and, as there is no legal aid in Guyana for constitutional appeals, lawyers are reluctant to take on such cases.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or in your own language:

- expressing deep regret at the execution of Ayube Khan and thus the resumption of executions in Guyana after more than five years break;
- urging that the death sentence on Rockcliffe Ross be commuted and that no further death warrants be signed;
- urging that, at the very least, no further executions should be carried out pending the outcome of the constitutional motion currently underway on behalf of Noel Thomas and Abdul Saleem Yasseen, which may have implications for others on death row;
- stressing that the resumption of executions is a retrograde step in the protection of human rights for all Guyana's citizens and is contrary to international standards and trends towards abolition of the death penalty;
- making some or all of the following general points about the death penalty: the death penalty has never been shown to deter crime more effectively than other punishment; it has a brutalizing effect upon all those who are involved in the process; execution is irrevocable and, despite the most stringent judicial safeguards, can be inflicted on the innocent.
