HAITI Gabriel LOUINE Romain CASTRI

Gabriel Louine and Romain Castri have reportedly been held in detention since 9 August 1994 at the Anti-gang investigation and research service - Service d'investigation et de recherches anti-gang in Port-au-Prince. Amnesty International is concerned for their safety, due to the constant reports of torture having taken place at the Anti-gang.

According to reports, these two young people were arrested by attachés in Delmas 60, Port-au-Prince, on 9 August. Neither of them have been brought before a judge which is in violation of the Haitian Constitution which states that detainees must be charged within 48 hours or released. They are reportedly being denied access to relatives.

Gabriel Louine and Romain Castri had apparently fled from their hometown of Poste-Avance, Camp-Perrin, Sud department, following accusations that they had participated in an alleged attack on a military barracks in Camp-Perrin in July 1994.

BACKGROUND INFORMATION

Haiti has been suffering a long-term human rights crisis, during which AI has received regular reports of extrajudicial executions, "disappearances," torture and arbitrary arrest, directed principally at supporters of President-in-exile Jean-Bertrand Aristide, but also affecting the population at large. Democratically elected President Aristide was overthrown by the military in September 1991. Since then Commander-in-Chief of the armed forces, General Raoul Cédras and Police Chief Michel François have effectively been ruling the country.

The expulsion in July 1994 of the United Nations (UN)/Organization of American States (OAS) international civilian observer mission to Haiti meant that Haiti lost its last international monitoring presence which might have helped to prevent further human rights violations.

On 31 July 1994 the UN Security Council meeting in special session passed Resolution 940 (1994) authorizing the formation of a multilateral force under unified command, opening the way to a US-led invasion of Haiti. In response, Haiti's $de\ facto$ government declared a state of siege, suspending constitutional guarantees.

RECOMMENDED ACTION: Please send telegrams and airmail letters either in French or in your own language:

- expressing concern about the continued detention of Gabriel Louine and Romain Castri without being brought to trial;
- urging that, while in detention, steps be immediately taken to ensure that their physical integrity be protected and that they be allowed access to relatives, a lawyer and a doctor;

- urging that they be charged with a recognisable criminal offence or else released.
