UA 269/97 Fear for safety 12 August 1997

HONDURASRamón Custodio López, human rights defender, and his family Members of CODEH

Concern for the safety of Ramón Custodio López, Director of the *Comité para la Defensa de los Derechos Humanos en Honduras (CODEH)*, Committee for the Defence of Human Rights in Honduras, his family and other members of CODEH, has been raised by recent heavy security force surveillance.

At 9pm on 9 August 1997, 15 men, allegedly members of the security forces, were reportedly covering the way in and out of "Los Dolores" square in the capital, Tegugcigalpa, where the home of Rámon Custodio and the offices of CODEH are located. Rámon Custodio lodged a complaint with the Director of the *Dirección de Investigación Criminal* (DIC), the Directorate of Criminal Investigations, who sent members of his office to check. However, the 15 men had vanished.

Amnesty International's concerns have been heightened by the fact that Ramón Custodio and other members of CODEH have long been the target of a campaign of intimidation, including death threats and surveillance, in an apparent attempt to restrict CODEH's legitimate activities.

BACKGROUND INFORMATION

As a result of their work to bring military personnel responsible for past human rights violations to justice, members of local NGOs, including CODEH, as well as the Commissioner for Human Rights and some judges, have been receiving death threats over a long period of time (for more information see: Continued struggle against impunity (AMR 37/01/96, March 1996) and The beginning of the end of impunity? (AMR 37/01/95, June 1995) as well as UA 97/97 (AMR 37/01/97, 10 April 1997) on the latest death threats to members of another Honduran NGO, COFADEH.)

Amnesty International believes that this increase in intimidation of human rights defenders is directly related to their efforts to expose serious past and present human rights violations in Honduras and to pressurize the authorities into bringing the perpetrators to justice.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or your own language:

- expressing serious concern for the safety of Rámon Custodio López, his relatives and members of CODEH following heavy security force surveillance against them;
- calling for a prompt and thorough investigation into the surveillance, and into previous threats and acts of intimidation against Rámon Custodio and CODEH members, and for those responsible to be brought to justice;
- urging the government to take immediate measures to guarantee the safety of Rámon Custodio, his relatives and members of CODEH, and asking to be kept informed of developments;

if possible, also:

- express support for the work of CODEH on behalf of victims of human rights violations;
- emphasise the need for appropriate protection to be given to all those involved in bringing to light the abuses committed by military in the past.
