## MEXICOMembers of Comité de Derechos Humanos Fray Pedro Lorenzo de la Nada and Enlace Comunicación y Capacitación, two human rights organizations in Chiapas state

Several members of two human rights organizations in the town of Ocosingo, Chiapas state, have been attacked. Amnesty International is concerned for their safety, and for that of other members of the two organizations.

On 12 June, a car knocked down Jaime Cuevas Mendoza, a member of *Enlace Comunicación y Capacitación*, Communication and Training Link, outside the home of Antonio Paoli Bolio, the coordinator of *Comité de Derechos Humanos Fray Pedro Lorenzo de la Nada*, Brother Pedro Lorenzo de la Nada Human Rights Committee. The car had reportedly been parked near Antonio Paoli Bolio's home, and drove straight at Jaime Cuevas as he approached the house. A nearby police car gave chase, but failed to catch those responsible. Jaime Cuevas was taken to hospital and treated for minor injuries. When the incident was reported to authorities, there was no one available to deal with the complaint.

A married couple working with both the *Enlace Comunicación y Capacitación* and the *Comité de Derechos Humanos Fray Pedro Lorenzo de la Nada* were targeted on the evening of 30 May, when unknown individuals forced their way into their home via the back door. The couple and their child were not at home at the time of the attack, but the attackers set fire to two rooms and the family's possessions. The couple immediately filed and official complaint, but the authorities reportedly failed to take any action to investigate the crime or identify those responsible.

The Enlace Comunicación y Capacitación and the Comité de Derechos Humanos Fray Pedro Lorenzo de la Nada are human rights organizations working in local communities in Chiapas.

## BACKGROUND INFORMATION

Since the armed uprising of the *Ejército Zapatista de la Liberación Nacional* (EZLN), Zapatista Army of National Liberation, in Chiapas in 1994, Amnesty International has documented a pattern of human rights violations against peasant and indigenous communities by the security forces and paramilitary or armed civilian groups.

In 1998 there were a spate of military operations against supposed supporters of the EZLN in the communities of Taniperla, Diez de Abril, Amparo Aguatina, Nicolás Ruiz and El Bosque. In Taniperla several members of the *Comité de Derechos Humanos Fray Pedro Lorenzo de la Nada* were detained and imprisoned for over a year.

Human rights defenders make a vital contribution to strengthening the rule of law, civil society and the development of institutions to protect human rights. However, in Mexico those who struggle to defend the rights of others have often been the first to come under attack, and to have their own rights violated and their safety threatened.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- expressing concern for the safety of members of the *Comité de Derechos Humanos* Fray Pedro Lorenzo de la Nada and Enlace Comunicación y Capacitación, and urging the authorities to guarantee their safety;
- expressing concern that the targeting of members of the two organizations appear to be an attempt to prevent their legitimate human rights work;
- calling on the authorities to carry out a prompt, thorough and impartial investigation into both incidents, with the results made public and those responsible brought to justice;
- reminding the authorities that the UN Declaration on the Rights and Responsibilities of Individuals, Groups and Institutions to Promote and Protect Universally Recognised Human Rights and Fundamental Liberties recognizes the legitimacy of the activities of human rights defenders and their right to carry out their activities without any restrictions or fear of reprisals.
