UA 251/04 Fear for safety/Human rights defender

MEXICO Pedro Raúl López (m)

His family

The president of the Chiapas State Human Rights Commission, Pedro Raúl López, has been suspended from his post by the State Congress, over allegations that he had obstructed investigations into the commission's finances. Amnesty International believes his suspension may actually be linked to his work investigating human rights violations by public officials in the state. He has been attacked and threatened before over his work in defence of human rights, and his family have also been intimidated so as to put pressure on him. Amnesty International is concerned for his safety and that of his family.

A few hours after he was suspended by the State Congress, state police agents (agentes estatales de investigación) reportedly detained his son-in-law, Moisés Cervantes Pérez. They took him to the office of the State Prosecutor (*Procuraduría General de Justicía del Estado*) in the city of Tuxtla Gutiérrez, where he was reportedly asked where Pedro Raúl López was. He was released without charge shortly afterwards. The same day, Pedro Raúl Lopez's daughter Martha López Santiago was stopped in the street by unidentified men who reportedly searched her bag but left without taking anything.

State Police (*Agencia Estatal de Investigación*) vehicles have reportedly been keeping Pedro Raúl López's house and the office of the Chiapas CEDH under surveillance. The local authorities are also reportedly attempting to undermine the work of the local human rights organization *Centro de Derechos Humanos Fray Bartolomé de las Casas*, by claiming it has overly close links with the CEDH.

The State Human Rights Commissions (*Comisiónes Estatales de Derechos Humanos*, CEDH) are quasi-autonomous bodies appointed and funded by state authorities. Their role is to investigate allegations of official human rights abuses. The quality and independence of these bodies varies widely between the 31 Mexican states. The work of the Chiapas CEDH improved considerably after Pedro Raúl López was appointed in June 2001, according to local NGOs. The CEDH has been involved in the investigation of a number of complaints of human rights violations including alleged torture of indigenous people by state police. In January 2002 shots were fired at his house and he began receiving anonymous threatening phone calls. In October 2002 he was attacked and beaten by armed men who warned him to stop telling the state government to investigate human rights abuses by the security forces (See UA 18/02, AMR 41/004/2002, 17 January 2002, and follow-up, AMR 41/033/2002, 17 October 2002.) The attack and the anonymous threats, have apparently not been investigated.

## RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- expressing concern for the safety of Pedro Raúl López, President of the Chiapas State Human Rights Commission, and his family;
- urging the authorities to take action to protect Pedro Raúl López and his family, in accordance with their own wishes;
- pointing out that there appears to have been no investigation into the intimidation and attacks that Pedro Raúl López suffered in 2002, and calling for a thorough investigation into these and the recent intimidation of Pedro Raúl López and his family, with those responsible brought to justice;
- reminding the authorities that the UN Declaration on the Rights and Responsibilities of Individuals, Groups and Institutions to Promote and Protect Universally Recognised Human Rights and Fundamental Liberties

recognizes the legitimacy of the activities of human rights defenders and their right to carry out their activities without any restrictions or fear of reprisals.
