UA 251/08 Torture

MEXICO Enrique Gómez Hernández (m)

Inmate Enrique Gómez Hernández has been tortured at Los Llanos state prison, in San Cristobal, Chiapas state. He had escaped from the prison in 2004, and was only returned there on 22 August.

He is serving a 25-year sentence for murder. Enrique Gómez told his wife that on the day he was put back in prison, at least five prison guards in civilian clothes attacked him. They made him run barefoot on gravel and whenever he stopped, they beat him with a stick. They then put his T-shirt over his face, and sprayed his body with teargas and hit him. When he fell to the ground, they kicked him in the back and legs. The guards threatened to beat him even more and leave him tied to a prison fence if he complained to a human rights organisation.

Since 26 August, a local human rights organisation has been asking permission to visit Enrique Gómez, with an independent doctor who would examine him and record the torture, but the prison director has so far refused.

Enrique Gómez is now held in a building called the "special observation area", where he is at risk of being attacked by prison guards and other inmates.

#### **BACKGROUND INFORMATION**

Reports of torture and other ill-treatment are common in Mexican prisons. Amnesty International documented attacks on prisoners by other prisoners, in Los Llanos prison earlier this year in UA 111/08 (AMR 41/019/2008, 25 April 2008). The authorities have not yet conducted adequate investigations into allegations of abuses.

# RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- calling on the authorities to ensure that Enrique Gómez is protected from further torture or other illtreatment;
- calling on them to order a full, prompt and impartial investigation of the torture he suffered, publish the results and bring those responsible to justice;
- urging them to ensure that he has access to appropriate medical attention and legal counsel, and is allowed to file a complaint about the torture with the relevant authorities and local human rights organizations;
- asking them to ensure that all prison officials are trained in and adhere to the UN Body of Principles for the Protection of All Persons under Any Form of Detention or Imprisonment and the Standard Minimum Rules for the Treatment of Prisoners.
