Amnesty International has learned that the following 12 people have been released out of the 19 people originally detained in Lima over a period of 5 days commencing 5 April 1992: **Roberto Ramírez del Villar, Eugenio Chang, Felipe Osterling Parodi, Aurelio Loret de Mola, Olmedo Auris, José Barsallo Burga, Soledad Lozano, Juan José Salazar, Fernando Reyes Roca, Alberto Alfaro Beltrán, Eduardo Del Carpio Begazo and Horacio Valladares Ayarza.** No further appeals on their behalf are necessary.

Appeals on behalf of the seven people who remain in detention should continue.

Thank you for your efforts in appealing on behalf of the detainees.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes

- requesting that the precise whereabouts of the seven people who remain in detention be publicly announced;
- asking that the legal status of the detainees be immediately clarified;
- asking that, unless charged with recognisably criminal offences, they be released immediately;

- urging that they be granted access to members of their family, and independent lawyers and doctors.
