According to reports, Agustín Mantilla continues to be detained but has been transferred to hospital for treatment of a medical condition not related to his detention. Appeals should continue on his behalf.

**FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/airmail letters**

- asking for clarification as to Agustín Mantilla's precise legal situation, including the charges he faces;

- asking that, unless he is charged with a recognizably criminal offence, he be released immediately;

- urging that he be granted regular access to members of his family, and independent lawyers and doctors.
