VENEZUELA: Amílcar RODRIGUEZ MACIAS  
and other prisoners

Ten prisoners, including Amílcar Rodríguez, were transferred from El Dorado to San Juan Juan de los Morros prison in the state of Guárico on 31 August. The transfer followed the visit to El Dorado of three state attorneys (fiscales) and a forensic doctor who confirmed the prisoners' poor medical condition.

On 11 September, Amílcar Rodríguez was transferred again to another prison in Caracas, Internado Judicial del Junquito, which is said to provide better facilities for the inmates.

The local human rights organization PROVEA, and the Comité de Familiares de Presos, Committee of Prisoners' Relatives, have sent a complaint to the Federación Médica Venezolana, Venezuelan Medical Federation, regarding the alleged involvement of medical personnel in the session in which Amílcar Rodríguez is said to have been tortured.

**FURTHER RECOMMENDED ACTION: Telegrams/telexes/express and airmail letters in SPANISH if possible:**

- stating that you have been informed of the transfer of some of the prisoners on the grounds of their medical condition and asking that they receive proper medical attention;

- urging that the allegations of ill-treatment be fully investigated, including allegations of involvement of medical personnel, and that criminal proceedings be brought against those whom there is found to be evidence of involvement in torture.
