Senior NLD leaders who had been asked to remain in their homes have now been allowed to "resume their daily activities as usual", the Myanmar authorities announced today.

There are reports that NLD vice chairman U Tin U, at least one other senior NLD leader and some foreign diplomats have been allowed to visit Daw Aung San Suu Kyi at her home.

Daw Aung San Suu Kyi and U Tin U had been held incommunicado since 2 September. The security forces had stopped them and other NLD members on 24 August as they left Yangon for a meeting. The group refused to turn back and stayed at the roadside in the Yangon suburb of Dallah until 2 September, when some 200 riot police forcibly returned them to Yangon.

Amnesty International has received no further information about the whereabouts of the 16 NLD Youth members named above, or about U Soe Myint, who were reportedly detained in Insein Prison after they were returned to Yangon.

BACKGROUND

The military authorities have launched a series of crackdowns on the National League for Democracy since the party won over 80% of the parliamentary seats in the May 1990 elections. The NLD has not been allowed to form a government, hundreds of its members are imprisoned for their peaceful political activities, and thousands have been forced to resign from the party.

Political prisoners in Myanmar are often tortured during interrogation by Military Intelligence after they are arrested. After sentencing they can also be tortured if they break arbitrary and harsh prison rules. Prison conditions are extremely poor. Political prisoners are denied adequate food, medical care, and sanitation, and dozens have died through lack of proper care.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or in your own language:

- welcoming the reported lifting of restrictions and end of incommunicado detention of Daw Aung San Suu Kyi, U Tin U and other NLD Central Executive Committee members;

- expressing concern for the safety of U Soe Myint and the 16 named NLD Youth members whose whereabouts and status have not been made public;
- urging that all those still detained should be allowed immediate access to lawyers, their families and medical treatment;
- urging the SPDC to release U Soe Myint and the 16 named NLD Youth members immediately and unconditionally, unless they are charged with a recognizably criminal offense.
