Amnesty International is concerned at the continuing harassment of workers' leaders. Wang Dawei, a labour protest leader in the city of Liaoyang in Liaoning Province, northeastern China was reportedly detained by police on 24 February, before being released four hours later. He had previously been detained following the workers' protest in March 2002. Amnesty International remains concerned for his safety as he is still at risk of detention by the police.

Wang Dawei was among a group of workers' leaders who planned to meet with Liaoyang municipal officials on 20 February 2003 to urge the release of Yao Fuxin and Xiao Yunliang and to press for a resolution to the ongoing disputes over corruption and lack of pay at many of Liaoyang's factories. Wang Dawei had intended to organize further protests in the city if negotiations between workers and officials broke down. He was reportedly going through the correct administrative procedures of applying to stage a protest when he was detained.

Yao Fuxin and Xiao Yunliang were tried on 15 January 2003 on charges of "subversion" but no verdict has yet been announced. They remain in custody and their families have not been able to visit them since the trial. Yao Fuxin is reported to be in poor health. The families of Yao Fuxin and Xiao Yunliang have reportedly been harassed by the police and told not to participate in any public protest, and not to petition Beijing on the matter, or to communicate with the news media.

Wang Zhaoming and Pang Qingxiang, who were originally arrested with Yao Fuxin and Xiao Yunliang in March 2002 and later released, remain under constant surveillance by the Public Security Bureau.

#### **BACKGROUND INFORMATION**

In March 2002, around 30,000 workers from 20 factories in Liaoyang demonstrated against layoffs, alleged corruption by management and delayed welfare payments. Government and factory officials have reportedly met some of the protesters' demands on back-pay and medical expenses, but a number of the protest leaders have been arrested and face long-term imprisonment or a life sentence if they are convicted on the charges against them.

# FURTHER RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Chinese or your own language:

- expressing concern that Wang Dawei was detained for exercising his legitimate right to organize a peaceful protest through officially sanctioned channels;

- urging the authorities to give a commitment that Wang Dawei and other workers' representatives or their families shall not in future be detained or otherwise harassed for any attempt to legally and peacefully exercise their right to freedom of expression and association;

- urging the authorities to make public any verdict and sentence against Yao Fuxin and Xiao Yunliang;

- urging the authorities to immediately and unconditionally release Yao Fuxin, Xiao Yunliang and all workers held in Liaoyang on charges originating from their peaceful protests;

- expressing concern that Yao Fuxin and Xiao Yunliang were charged with "subversion" solely for peacefully exercising their rights to freedom of expression and association, and expressing concern that subversion charges continue to be used widely to imprison and detain rights activists.
