INDIAGovindaswamy

On 15 March 2000, Govindaswamy was granted a 15-day stay of execution. The stay was ordered the same day that the media reported that his execution had been set for 0500 hrs (Indian Standard Time) on 16 March in Tamil Nadu.

The office of the Home Secretary granted the stay after human rights activists had made appeals on 15 March to the President to grant one, pending consideration of outstanding clemency petitions filed by them.

Clemency petitions earlier filed by Govindaswamy with the Governor of Tamil Nadu and the President had all been rejected.

This is the second stay of execution granted to Govindaswamy who was initially scheduled to be put to death on 9 November 1999.

Govindaswamy, an inmate at Coimbatore Central Prison in the state of Tamil Nadu, was tried in 1985 for the murder of 5 people the year before. In 1987 he was acquitted on the grounds that the prosecution case was not proved beyond doubt. In 1997, however, after the government appealed against his acquittal, the High Court reversed this judgement and sentenced him to death. In 1998 the Supreme Court dismissed an appeal and upheld the death sentence. A clemency petition to the President was later rejected and an execution date set.

FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in English or in your own language:

- expressing grave concern that an execution date was set for Govindaswamy, an inmate at Coimbatore Central Prison in the state of Tamil Nadu, despite clemency petitions from human rights organizations pending before the Governor of Tamil Nadu and the President;
- welcoming the temporary stay of execution but urging the President to commute his death sentence;
- expressing unconditional opposition to the death penalty as a violation of the right to life and the right not to be subjected to cruel, inhuman or degrading treatment or punishment, and emphasising that the death penalty has never been shown to have a special deterrent effect.
