## INDONESIAJunaidi (m), aged 37

Junaidi, the head of the Aceh Besar District branch of the pro-independence group Information Centre for a Referendum in Aceh (SIRA), was detained by members of Kostrad (Army Strategic Reserve Command) at around 1 pm on 8 January. He has not been seen since. Political activists, including members of SIRA have been tortured in detention and there are serious concerns for Junaidi's safety.

According to witnesses, Junaidi and a friend, who were visiting the office of the head of the District in Jantho town, Seulimeum Sub-district, Aceh Besar District on work-related business, were stopped by a group of uniformed Kostrad officers. Junaidi was then taken away and at around 5 pm on the same day, Junaidi's older brother received a phone call from him saying that he was being detained in the Seulimeum Sub-district area. It is not known why Junaidi was taken away, but his detention is thought to be linked to his activities with SIRA.

SIRA has recently received information that Junaidi was being held in military or police custody, possibly in the Brimob headquarters in Banda Aceh town, Aceh Besar District. The military however has denied detaining him.

#### BACKGROUND INFORMATION

Serious human rights violations, including unlawful killings, "disappearances", torture and arbitrary arrests, are continuing in Aceh during military and police operations against the armed opposition group, Free Aceh Movement (*Gerakan Aceh Merdeka*, GAM). Local human rights groups have reported that around 1,500 people were killed during military operations in 2001, most of them civilians. GAM has also been responsible for human rights abuses.

Anyone detained by the police or military in Aceh is at grave risk of torture, ill-treatment or other human rights violations. On 19 September 2000, two SIRA activists were taken into custody in Banda Aceh and tortured. Two other leading SIRA activists have been imprisoned as prisoners of conscience in the past year.

# RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Bahasa Indonesia or English or your own language:

- urging the authorities to immediately clarify the whereabout of Junaidi and the reasons for his detention;
- urging the authorities to provide guarantees that he will not be subjected to torture, ill-treatment or other human rights violations, and that he is given immediate access to lawyers, his family and medical attention;
- urging the authorities to ensure that Junaidi is released immediately and unconditionally unless he is to be charged with a recognizably criminal offence.
