### EAST TIMORTens of thousands of East Timorese refugees

The condition of some 200,000 refugees in West Timor is deteriorating as pro-integration militia groups continue to prevent access to humanitarian aid, including deliveries of food, medical and other essential supplies.

Reports of abductions, threats and "disappearances" of refugees by pro-integration militias in West Timor continue to be received. The whereabouts of six young men abducted by militias in Atambua on 27 September 1999 is still unknown.

Human rights defenders, humanitarian workers, students and political activists are among those most at risk of human rights violations and may be prevented from leaving Indonesia independently.

Elsewhere in Indonesia, including Java, Sumatra, Bali, Flores and Sulawesi, East Timorese people have been threatened and in some cases attacked including student activists who fled to the capital Jakarta.

The Indonesian government says these refugees can return to East Timor. At the same time it has announced the start of a "voluntary" selection process for up to 100,000 East Timorese refugees willing to be relocated within Indonesia, under a government transmigration scheme. Amnesty International is concerned that continued intimidation by militia groups means that the refugees are not in a position to freely consent to relocate in Indonesia or to return to East Timor. There are reports that some refugees in West Timor have been denied food because they expressed a desire to return to East Timor.

# FURTHER RECOMMENDED ACTION: Please send faxes/express/airmail letters in English or Bahasa Indonesia or in your own language:

- expressing concern at continued reports of human rights violations, including abductions, threats and "disappearances" of refugees by pro-integration militias in West Timor and other parts of Indonesia;
- urging the Indonesian authorities to protect East Timorese refugees in West Timor and other parts of Indonesia from threats and attacks by the militias, the Indonesian National Army (TNI) and the police;
- requesting that they grant UNHCR and other humanitarian agencies full and unimpeded access to refugees in West Timor to give humanitarian assistance; urging them to ensure that refugees are able to exercise their rights, in accordance with international human rights standards;
- calling additionally on the Minister of Transmigration to halt implementation of the transmigration project until it can be demonstrated that conditions exist for refugees to make their decision freely with effective monitoring by UNHCR and other independent agencies.
