MUNIANDY N., stenographer, 54 years old PACKIAM M., domestic helper, 41 years old

N. Muniandy and M. Packiam were sentenced to death on 15 November 1990 for trafficking in 226.33g of heroin on 21 December 1985. An appeal heard on 23 March 1994 by the Supreme Court has now upheld the sentences imposed on both men.

An appeal by a third man, Mohamed Ruslay Zakaria, was heard on the same day. He was found guilty of drug possession and his sentence commuted to 10 years' imprisonment. The High Court had sentenced him to death for drug trafficking in February 1989.

The only hope of N. Muniandy and M. Packiam for a pardon or commutation now resides with the $Yang\ di-Pertuan\ Negeri\ (ruler)$ of the state.

BACKGROUND INFORMATION

In Malaysia, the death penalty is mandatory for a number of offences: murder, drug-trafficking, unauthorised possession of firearms and use of firearms with intention to cause injury or death.

In 1975 the Dangerous Drugs Act of 1952 was amended, making the death penalty the maximum sentence for drug-trafficking. Since April 1983 the death penalty has been mandatory for drug-trafficking on conviction of possession of 15 grams of heroin or morphine, 200 grams of cannabis, or 1,000 grams of opium.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes and airmail letters either in English or in your own language:

- stating that Amnesty International opposes the death penalty in all cases as a violation of the right to life and the right not to be subjected to cruel, inhuman or degrading treatment, as proclaimed in the Universal Declaration of Human Rights;
- welcoming the commutation of Mohamed Ruslay Zakaria's sentence;
- expressing concern at the imposition of the death penalty on N. Muniandy and M. Packiam and urging that the sentences be commuted.
