On 14 April 1992, around 2 p.m., a group of army personnel accompanied by members of the Tamil Eelam Liberation Organization (TELO), an armed group working in conjunction with the military, reportedly killed deliberately all the members of the family of Thambimuttu Suppiah, his wife and five children, and a neighbour present in their house at Mandur, Batticaloa district.

The eight civilians were allegedly killed in reprisal for the killing earlier that day of two members of TELO by members of the Liberation Tigers of Tamil Eelam (LTTE), who had been lying in ambush near the house of the above family. Witnesses allege that other TELO members returned to the spot about one hour later after the killing of their two members, accompanied by army personnel, and entered the family's house. The witnesses said they heard shots. Later, the bodies of the victims were found with bullet wounds. It was also alleged that some of them had stab wounds. The bodies were taken to Batticaloa hospital, where a post mortem was carried out. The victims have since reportedly been buried.

Several newspapers, including $\underline{\text{The Island}}$ and the $\underline{\text{Daily News,}}$ carried articles the next day suggesting that seven civilians had been killed in a crossfire at Mandur, Batticaloa district.

Amnesty International is calling upon the government to establish a full and impartial investigation into this incident and to bring to justice those found responsible.

BACKGROUND INFORMATION

The armed conflict between the security forces and the Liberation Tigers of Tamil Eelam (LTTE) which resumed in June 1990, continues throughout the northeast of Sri Lanka. In the Batticaloa district in the east, the fighting has been restricted mainly to the rural areas. The LTTE has established camps in the jungle, from where it occasionally launches attacks on the security forces and Tamil armed groups cooperating with them.

The Sri Lankan press regularly carries articles referring to the killing of civilians in crossfire between the security forces and its allies, and the

LTTE. It is often impossible for observers to ascertain the exact circumstances of these killings. The details provided by the witnesses to the above incident, however, suggest that the members of this family and their neighbour were deliberately killed in an apparent reprisal for the killing of two members of TELO near their home.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters:

- expressing concern about reports of the extrajudicial killing of Thambimuttu Suppiah, his wife and five children and their neighbour on 14 April 1992 at Mandur, Batticaloa district in apparent reprisal for the killing of two members of TELO by the LTTE;
- urging the government to institute an independent and impartial inquiry into their killing, and to bring to justice those found responsible;
- urging that all possible steps be taken to halt extrajudicial killings by the security forces and armed groups working in conjunction with them.
