KINGDOM OF THAILANDUp to 16 people on death row

Hla Win, a Myanmar national, was executed in Bang Khwaang Maximum Security Prison on 4 January 2000 for heroin trafficking. He had been in prison since 1993 and had exhausted all his appeals against the death sentence. His execution comes after 16 people were put to death in 1999, an unprecedentedly high number, contrary to United Nations recommendations.

Prison officials have reportedly said that there are now nine people on death row who have exhausted all appeals. Amnesty International is unable to confirm that this number is correct. All face imminent execution. There are believed to be more than 100 people sentenced to death who have still to complete the appeals procedure.

Ten more death sentences were imposed in December 1999. Three men were sentenced to death for murder, and seven for importing methamphetamine pills with intent to supply. All 10 men may now appeal against their death sentences to the Supreme Court.

- condemning the execution of Hla Win on 4 January 2000, and the continuing imposition of the death penalty, with at least 10 people sentenced to death in December 1999;
- expressing concern that at least nine, and possibly as many as 16 people who have exhausted all their appeals face imminent execution;
- urging an immediate moratorium on all executions, commutation of all outstanding death sentences and the removal of the death penalty from all legislation, in line with international standards and recommendations from the United Nations Commission for Human Rights adopted in its most recent resolution in April 1999.
