RUSSIA: Further deaths reported after Russian troops fire on people leaving the Chechen Republic-Ichkeriya

Amnesty International has received further reports that people seeking to flee the continuing armed conflict in the self-proclaimed Chechen Republic-Ichkeriya have been shot dead by Russian troops.

Seven people, including five women and a three-month-old baby girl, were reportedly shot dead on 7 March 1995 by Russian troops who opened fire on a convoy of two vehicles, a car and a bus, containing people seeking to leave the conflict zone. According to Lidiya Mushayeva, a survivor of this incident, the vehicles contained mostly women and children who were trying to escape from the village of Achkhoy-Martan (south-east of the Chechen capital Grozny), which was being shelled by Russian forces.

Lidiya Mushayeva recounted that the convoy had checked to see whether the road to the neighbouring republic of Ingushetiya was safe before setting off and local leaders had given the go-ahead. However, soon after the car and bus left Achkhoy-Martan they were fired on by Russian troops.

According to Lidiya Mushayeva the troops were only 25-30 metres away from the vehicles when they started firing. The driver of the car, Lidiya Mushayeva's 22-year-old nephew, was killed instantly. So was her three-month old baby daughter, who had been placed in the back of the car. Her sixteen-year old daughter (the oldest of her four children) was badly wounded and died later in hospital. Four women in the bus were also killed. Survivors left the vehicles and continued to come under fire as they ran for cover. Lidiya Mushayeva herself received bullet wounds to her chest and is recovering in hospital.

The self-proclaimed Chechen Republic-Ichkeriya declared independence in 1991, a move not recognized by Russia or internationally. Thousands of people, including many civilians, are reported to have died in the armed conflict which began after Russian troops entered the territory on 11 December 1994.

Amnesty International takes no position on territorial disputes, but is urging all parties to the conflict to protect non-combatants in accordance with international humanitarian and human rights law. Amnesty International has already appealed to the Russian authorities concerning an incident on 17 December 1994 in which a convoy of vehicles reportedly containing people seeking to flee the fighting was fired upon by Russian troops. It is urging the Russian authorities to ensure that comprehensive and impartial investigations are conducted into all incidents in which Russian troops are alleged to have opened fire on people fleeing the fighting in the Chechen Republic-Ichkeriya; that the results are made public; and that any persons found responsible for violations are brought to justice within the bounds of international law.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters

- urging the Russian authorities to hold a comprehensive and impartial investigation into the incident described above, with the results made public and any persons found responsible for violations brought to justice within the bounds of international law;
- urging that all necessary steps are taken to ensure that non-combatants are protected in accordance with international humanitarian and human rights law.
