PUBLIC APPEAL Belarus End the Silencing of Human Rights Defenders

Belarus is a country where the theory of human rights on the one hand, and everyday implementation on the other, diverge widely. Even though a whole spectrum of human rights and fundamental freedoms are guaranteed in the country's laws and constitution, and Belarus is a party to most of the international and regional human rights treaties, an inordinate gap between law and practice continues to exist. In the light of the deteriorating human rights situation, human rights defenders in Belarus - as in many societies - have a central role to play, both defending the rights of Belarusian citizens and raising the overall awareness of human rights within the country.

In the course of their work human rights defenders in Belarus face a deliberate campaign on the part of the Belarusian authorities to frustrate and undermine their activities, aimed at silencing them.

In recent months a disturbing number of non-governmental organizations (NGOs), directly and indirectly engaged in the promotion and defence of human rights in Belarus, have been closed by a judiciary whose independence has been repeatedly called into question by the international community (see *Human Rights Defenders under Pressure in Belarus* AI Index: EUR 49/004/2003). On 29 October 2003 the Belarusian authorities closed one of Belarus' most prominent human rights organization, *Spring-96*, as a further attempt to suppress what remains of the country's human rights community.

As in the case of several other human rights NGOs, the court ruled that *Spring-96* had violated several provisions of a highly controversial law which tightly regulates the activities of civil society. In one instance, the court reportedly ruled that in rendering legal assistance to individuals who were not members of the human rights organization, *Spring-96* had violated the law. On 13 October another leading human rights organization, *Legal Assistance to the Population*, whose staff members have been active in determining the fate of Belarus "disappeared" opposition figures, was shut down by the Supreme Court on grounds equally as spurious.

Amnesty International is concerned that the closures of the NGOs, referred to above, were in violation of international human rights law and standards. The rights of freedom of

association and peaceful assembly are enshrined in Articles 21 and 22 of the ICCPR, to which Belarus is a state party. These rights are also enshrined in the United Nations (UN) Declaration on the Right and Responsibility of Individuals, Groups and Organs of Society to Promote and Protect Universally Recognized Human Rights and Fundamental Freedoms, otherwise known as the Declaration on Human Rights Defenders.

Urgent action is needed. Please write appeals calling on the Belarusian authorities to:

- stop the deliberate pattern of obstruction, harassment and intimidation of human rights defenders, by closures, and threats thereof, of several NGOs, including *Legal Assistance to the Population, Spring-96* and the *Belarusian Helsinki Committee*, directly and indirectly engaged in the promotion and defence of human rights in Belarus;
- immediately review laws, regulations and administrative practices relating to the registration and activities of non-governmental organizations in order that their establishment and free operation may be facilitated in accordance with Articles 21 and 22 of the International Covenant for Civil and Political Rights;
- adhere to the principles of the UN Declaration on Human Rights Defenders (Declaration on the Rights and Responsibility of Individuals, Groups and Organs of Society to Promote and Protect Universally Recognized Human Rights and Fundamental Freedoms, adopted by the United Nations General Assembly, 9 December 1998.
