Further information on UA 271/96 (EUR 50/14/96, 21 November 1996) - Death penalty / Legal concern

UKRAINEVladimir Yureyvich CHERNITSA, aged 23

Amnesty International has learned that Vladimir Chernitsa's petition for clemency has still not been considered by the Clemency Commission or the President. The petition was sent to President Kuchma on 11 September 1996. The clemency petition is the final possibility for appeal against the death sentence and is therefore Vladimir Chernitsa's last chance of avoiding execution.

BACKGROUND INFORMATION

On 29 January the Parliamentary Assembly of the Council of Europe passed Resolution 1112 (1997) in which it condemns Ukraine's failure to honour the commitment made on her accession to the Council to put in place a moratorium on the use of the death penalty and deploring the executions which took place in 1996. The resolution continued, " The Assembly warns the Ukrainian authorities that it will take all necessary steps to ensure compliance with commitments entered into. In particular, should any more executions of the death penalty be carried out following the adoption of this resolution, the Assembly may consider the non-ratification of the credentials of the Ukrainian parliamentary delegation at its next session."

FURTHER RECOMMENDED ACTION: Please send a further round of appeals by telegram/fax/express or airmail letter in Ukrainian, Russian or English or in your own language:

To President Kuchma:

- urging him to immediately take the political decision not to sign any more execution orders, in keeping with the solemn commitment made by Ukraine to impose a moratorium on executions from the day of her accession to the Council of Europe;

- urging him to commute to Vladimir Chernitsa's death sentence and all others which come before him.

To the Head of the Clemency Commission:

- urging that the Clemency Commission recommends clemency for Vladimir Chernitsa.
