The death sentences passed by the Supreme Military Court in Cairo on 15 October 1997 against the three people mentioned above have been confirmed by the Military Appeals Bureau and ratified by President Hosni Mubarak. The execution of 'Adel 'Ali Bayyoumi is now imminent.

The three people were among 85 (amended figure) defendants tried in the case known as the "Khan al-Khalili Case". Charges against them included membership of a secret organization, al-Gihad (Holy War), with aims to overthrow the government, criminal collusion, possession of weapons and anti-government leaflets, and planning to plant explosives in the Khan al-Khalili market in Cairo. 'Adel 'Abd al-Magid and Ahmad Ibrahim al-Sayyid al-Naggar were sentenced to death in absentia. Two other defendants were sentenced to life imprisonment with hard labour and 49 were sentenced to between 14 years' imprisonment with hard labour to two years' imprisonment. The court acquitted 31 defendants.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Arabic, English, French or in your own language:

- expressing concern that the death sentences passed against the three people mentioned above on 15 October 1997 have been ratified and urging the President to use his constitutional powers to grant clemency and commute these and all other pending death sentences;
- expressing concern that the defendants were tried before a military court and that the trial did not comply with international standards for fair trial including Article 14 of the International Covenant on Civil and Political Rights (ICCPR) to which Egypt is a state party;
- expressing concern at the continuing extensive use of the death penalty in Egypt and drawing attention to world trends to abolish or reduce the use of the death penalty, in accordance with Article 6 of the ICCPR.
