EGYPTSha'ban 'Ali 'Abd al-Ghani

Sha'ban 'Ali 'Abd al-Ghani has been sentenced to death for his alleged part in the activities of an armed Islamist group. He has no right of appeal against his sentence, announced by the court on 13 April, and he can only escape the gallows through a Presidential pardon.

He and 13 other alleged members of the group were charged with offences including the murders of policemen, and bank robberies, carried out in 1994-96 in Upper Egypt. Nineteen members of the group were reportedly killed during police raids on their hideouts.

The trial, known as the "terrorist organization of Upper Egypt" case, began at the Cairo (Emergency) Supreme State Security Court (ESSSC) in 1999. There is no right to appeal against ESSSC sentences. This violates the International Covenant on Civil and Political Rights (ICCPR), to which Egypt is a state party, which guarantees all convicts the right to have their sentence reviewed by a higher tribunal.

Sha'ban 'Ali 'Abd al-Ghani's sentence has now been passed to the *Mufti*, Egypt's highest religious authority, for approval. This is a routine measure, and the Mufti is not known to have refused to approve any death sentence in recent years.

The ESSSC is expected to announce its verdicts on all the defendants on 10 May, after which this death sentence will be passed on to the President of the Republic or his nominee for ratification.

BACKGROUND INFORMATION

The death penalty has been used extensively in Egypt in the last few years for criminal offences such as drug use or trafficking, murder and offences related to "terrorism". In 1999, at least 108 people were sentenced to death and at least 16 people were executed.

In October 1992 President Hosni Mubarak began issuing special decrees referring civilians for trial at military courts. These courts have sentenced 94 civilians to death, of whom 67 have been executed.

- acknowledging the right and duty of states to bring to justice those responsible for violent crimes, but explaining your opposition to the death penalty in all cases as a violation of the right to life and the most extreme form of cruel and inhuman punishment, stressing that there is no evidence that it is an effective deterrent to such crimes;
- urging the Mufti not to ratify this death sentence;
- urging the President to use his constitutional powers to grant clemency to Sha'ban 'Ali 'Abd al-Ghani and to commute this and all other pending death sentences;
- expressing concern at the continuing extensive use of the death penalty in Egypt and drawing attention to world trends to abolish or reduce the use of

the death penalty, in accordance with Article 6 of the ICCPR, to which Egypt is a state party.
