Further information on UA 107/98 (MDE 12/20/98, 8 April 1998) - <u>Death Penalty/ Legal</u> Concern

EGYPTSa'eed 'Abd al-Hakim Mostafa Mostafa Hamza (in absentia)

Sa'eed 'Abd al-Hakim Mostafa could be executed within weeks.

The death sentences passed on him and Mostafa Hamza, who is believed to be in Afghanhistan, have been approved by the Mufti, Egypt's highest religious authority, and were confirmed by an (Emergency) Supreme Security court in Cairo on 4 May 1998. There is no right of appeal against verdicts by (Emergency) Supreme Security courts.

This case, known as "the returnees from Sudan and Afghanistan", involves 22 men charged with plotting to overthrow the government and membership of the forbidden armed Islamist group "al-Gama'a al-Islamiya".

Apart from the two men sentenced to death, three others have been sentenced to life imprisonment with hard labour. Six men were given 15 years with hard labour, and another three were sentenced to 10 years with hard labour.

A further three defendants were respectively sentenced to one, three and five years in prison. The remaining five were acquitted.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Arabic, English, French or in your own language:

- urging the President to use his constitutional power to grant clemency to Sa'eed 'Abd al-Hakim Mostafa and Mostafa Hamza and commute these and all other pending death sentences;
- expressing concern at the extensive use of the death penalty in Egypt, and explaining your opposition to the death penalty as it violates the right to life and is the most extreme form of cruel and inhuman punishment;
- pointing out that while you recognize the right of states to bring criminals to justice, there is no evidence showing that the death penalty is an effective deterrent to crime;
- drawing attention to world trends to abolish or reduce the use of the death penalty, in accordance with Article 6 of the International Covenant on Civil and Political Rights.
