Amnesty International fears that the married couple named above will be flogged after being convicted of "involvement in prostitution" by a summary court in Jouf, in the north of the country. According to Saudi Arabian press reports of 1 September, the individuals, named only as Robin and Nora, were sentenced to 90 lashes as well as three months imprisonment, to be followed by deportation to the Philippines. Amnesty International does not know the precise charges upon which their convictions were made.

BACKGROUND INFORMATION

Flogging is mandatory in Saudi Arabia for a number of offences, including sexual offences, and can also be used at the discretion of judges as an alternative or addition to other punishments. Sentences can range from dozens to thousands of lashes.

To date this year, Amnesty International has recorded at least 80 cases of floggings being carried out in Saudi Arabia, with the number of lashes ranging between 10 and 70 in each case.

In 1997, the United Nations commission on human rights stated that "corporal punishment [such as flogging] can amount to cruel, inhuman or degrading punishment, or even to torture". As a state party to the Convention Against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment (CAT), Saudi Arabia is in violation of this international standard by carrying out the punishment of flogging.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English, Arabic or your own language:

- -expressing concern at the reports that Robin and Nora are to be flogged and calling for the sentences not to be carried out;
- -asking to know the precise charges against them, together with details of their trial proceedings and the evidence produced against them;
- -asking whether they have been allowed defence lawyers of their own choosing, and whether they are allowed to appeal against their convictions and sentences; -stating that you consider the use of flogging as punishment to be cruel, inhuman and degrading, contrary to CAT and Article 5 of the Universal Declaration of Human Rights, which states: "No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment."
- seeking assurances that they will be provided with access to family, legal and consular access in detention, as well as regular medical attention as and when it is necessary;
