## **URGENT ACTION** DETAINED PROTESTORS REMAIN AT RISK

# Khaled al-'Omair and Mohammed al-'Otaibi remain in detention and are at risk of torture or other ill-treatment. They were detained in Saudi Arabia after taking part in, or attempting to demonstrate against Israel's military action in Gaza. They appear to be prisoners of conscience, detained solely for the peaceful exercise of their right to freedom of assembly.

Sources in Saudi Arabia have stated that Khaled al-'Omair and Mohammed al-'Otaibi were charged at around the end of June with participating in a protest. Khaled al-'Omair is reported to have been informed more recently by the prosecution that the charges against him and Mohammed al-'Otaibi have been dropped, but the two men nonetheless continue to be detained at al-Ha'ir Prison in Riyadh.

Khaled al-'Omair and Mohammed al-'Otaibi were arrested on 1 January in al-Naheda Street, in the capital, Riyadh, where a protest against Israel's military action in Gaza had been due to take place.

Kamil 'Abbas al-Ahmad, Zuhair al-Janbi and 11 other protestors who were arrested in connection with this and other similar protests that took place in December 2008 were released without charge or trial in December 2008 and January 2009.

#### PLEASE WRITE IMMEDIATELY in Arabic or your own language:

- expressing concern that Khaled al-'Omair, and Mohammed al-'Otaibi remain in detention;
- seeking clarification of the reasons for their detention
- urging the authorities to ensure that they are protected from torture and other ill-treatment;
- calling on the authorities to ensure that the men are given regular access to their families and lawyers, and any medical attention they may require;
- calling on the authorities to ensure that the men are given the opportunity to challenge the legality of their detention;
- calling on the authorities to release them immediately and unconditionally if they are being held solely for taking part in or attempting to hold peaceful protests.

#### **ADDITIONAL INFORMATION**

Demonstrations are not allowed in Saudi Arabia. Those who defy this ban are often held incommunicado without charge, denied access to the courts to challenge the legality of their detention, and tortured or otherwise ill-treated. If and when detainees are brought to trial, the proceedings generally fall far short of international fair trial standards: in many cases, defendants are denied legal counsel; court hearings are held behind closed doors; and defendants and their families are not informed of the progress of legal proceedings against them.
