# Fear of torture/Incommunicado detention

# SAUDI ARABIAGeorge Thomas, Indian national, aged 38-40

George Thomas, an Indian national working in Saudi Arabia, was reportedly arrested outside his home, as he returned from a Catholic worship service. Amnesty International is concerned that he may have been arrested solely for his religious beliefs, and if so would consider him a prisoner of conscience.

His whereabouts are now unknown to Amnesty International and are also said to be unknown to his relatives and friends. As he is detained incommunicado, he is at risk of torture.

#### BACKGROUND INFORMATION

Members of faiths other than Sunni Islam are not permitted to practice their religions in public, and risk arrest even if they do so in private. Several Christians were arrested in June 1998, possibly solely because of their religious beliefs. They were eventually deported. (See UA 184/98, MDE 23/05/98, 26 June 1998 and follow-up MDE 23/10/98, 11 September 1998)

# RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or your own language:

- asking to know where George Thomas is held, and seeking assurances that he is treated humanely, protected from torture, and given prompt and regular access to his relatives, lawyers and medical attention as necessary;
- expressing concern that George Thomas may be detained solely for his religious beliefs, and, if so, calling for his immediate and unconditional release as a prisoner of conscience;
- otherwise, asking why he was arrested, whether he has been charged with any recognizably criminal offence, and asking whether any trial proceedings are underway.
