Health professionals imprisoned in 1980 SYRIA

In June 1995, Amnesty International issued information on the arrest of over 100 health professionals in 1980 following a strike called by professional associations in April of that year. The strike was the culmination of protests led by the Syrian Bar, Medical and Engineers' Associations to call for an end to the state of emergency in force since 1963 and a restoration of rights and legal safeguards.

It was believed that many of the health professionals arrested at the time could still be in prison without charge or trial. Although a small number were known to have been released, executed or to have died in prison, no information about the whereabouts of the majority had been provided by the authorities.

Amnesty International has now received a letter from the Syrian Embassy in London stating that the authorities in Damascus had forwarded a list of individuals who had been the subject of Al appeals and who were in fact released. The list included 18 of the health professionals arrested in connection with the 1980 strike. (Not all the releases are recent - the dates of a few are given as being in the 1980s; others are in the early 1990s, around the time of Presidential amnesties which were declared in December 1991 and March 1992.)

The numbers in brackets relate to the numbering system used in the information issued by Amnesty International in its action of 19 June 1995.

The asterisks against three of the names indicate that these are assumed to be the same individuals as those named by the embassy. (In a few instances, AI did not initially have the full family name.) The names given in the letter from the embassy were:

- ** 'Abd al-'Aziz Haj Salih
- *** Bissam Taha

A total of 48 people were named in the letter as having been released, the remainder being individuals arrested at different times in unrelated cases. No specific reference was made to the mass arrests in 1980 and no information was given on any of the other health professionals whose names appeared in the June 1995 action.

Recommended Actions

Letters can therefore continue. Letters should

- welcome the recent news that some of the health professionals arrested following a one-day strike in March 1980 have apparently been released
- call for the unconditional release of any health professionals who are still held following the 1980 strike
