Dr 'Abd al-'Aziz al-Khayyir is a physician and member of the *Hizb al-'Amal al-Shuyu'i* (Party for Communist Action, PCA). He has been in custody since 1992 and is currently held in Sednaya prison in Damascus. He was convicted of charges relating to his political affiliation and beliefs rather than any act of violence. He has been adopted by Amnesty International as a prisoner of conscience and the organization is seeking his unconditional release. Dr al-Khayyir is the only remaining member of the PCA to remain in prison. In December 2001, all those imprisoned with Dr al-Khayyir were released as part of a presidential amnesty. Amnesty International does not know why he was exempted from the amnesty.

Recommended actions & addresses

- welcoming the recent releases of political prisoners in Syria;
- expressing concern at the continued detention of Dr 'Abd al-'Aziz al-Khayyir in Sednaya Prison;
- stating that you consider that Dr 'Abd al-'Aziz al-Khayyir is a prisoner of conscience held solely for the expression of his political views;
- noting that he is the sole member of his political group to remain in custody;
- urging the authorities to release Dr 'Abd al-'Aziz al-Khayyir unconditionally.

IMPRISONED DOCTOR

Dr 'Abd al-'Aziz al-Khayyir Svria

Introduction

Dr 'Abd al-'Aziz al-Khayyir is a physician and member of the *Hizb al-'Amal al-Shuyu'i* (Party for Communist Action, PCA). Dr al-Khayyir is the only remaining member of the PCA to remain in prison. In December 2001, all those imprisoned with Dr al-Khayyir were released as part of a presidential amnesty. Amnesty International does not know why he was exempted from the amnesty.

Background information

Dr 'Abd al-'Aziz al-Khayyir was arrested in Damascus on 1 February 1992 by members of al-Mukhabarat al-'Askariyya (Military Intelligence) in connection with the prohibited *Hizb al-'Amal al-Shuyu'i* (Party for Communist Action, PCA).

'Abd al- 'Aziz al-Khayyir was eventually tried and, sentenced in August 1995, by the Syrian State Security Court (SSSC) to 22 years' imprisonment (the longest sentence known to have been handed down by the SSSC) on charges of membership of the PCA. Amnesty International considers 'Abd al-'Aziz al-Khayyir to be a prisoner of conscience who was arrested, detained and convicted for his conscientiously-held beliefs and political affiliation. Four other prisoners put on trial at the same time were also adopted as prisoners of conscience and have now been released.

'Abd al-'Aziz al-Khayyir has been imprisoned on grounds of his membership of the PCA. The PCA is not known to have used or advocated violence.

'Abd al-'Aziz al-Khayyir and his co-defendants were charged collectively with the following offences:

- belonging to an association formed with the aim of changing the fundamental economic and social structure of the state by terrorist means (under Article 306 of the Penal Code);
- carrying out activities opposed to the socialist system of the state (Article 3[a] & Article 4[a] of the Legislative Decree No. 6, 1965);
- opposition to the aims of the revolution (Article 3e & article 4c of the Legislative Decree No. 6, 1965).

The prosecution's indictment was primarily based on an analysis of the political program of the PCA to substantiate the charges. There was no material evidence to prove or even suggest that the defendants had committed or planned any violent or "terrorist" actions as the prosecution claimed, and no reference made to the "terrorist means" as provided for under Article 304 of the Penal Code.

Prison health care

The prison doctors, who are seen infrequently by prisoners, are military police doctors who are newly graduated and, in many cases, carrying out compulsory service in prison. In practice it has been the medically-trained prisoners who have diagnosed and recommended treatment for sick prisoners. The prison doctors themselves are reported to place great value on the opinion of the prisoner-doctors who have much more experience. Simple medication is available within the prison but anything more specialised has to be brought by family members.

In the recent past, Dr al-Khayyir is reported to have been permitted to move more freely around the prison and to have been able to provide medical care to a greater number of prisoners. While this has represented an improvement in the medical care for the prisoners it has apparently increased his workload.
