SYRIA 'Abdalla Ahmad Muhammad, 71

'Abdallah Ahmad Muhammad, a 71-year old Iraqi Kurd believed to have been travelling on a Swedish passport, was reportedly arrested on 22 August 1999 on his arrival from Sweden. He has since been detained incommunicado, and Amnesty International fears that he may be tortured and ill-treated. He suffers from chronic heart and kidney problems, and needs regular medication.

After his arrest by Syrian security forces at Damascus airport he was apparently taken to Far' Falastin (Palestine Branch) detention centre in Damascus. His wife and son, who had travelled with him, were allowed to continue their journey to Iraqi Kurdistan.

'Abdallah Ahmad Muhammad has previously suffered three heart attacks and has only one kidney. It is feared that he may be lacking medication and is being denied access to his family and a doctor. He is reportedly no longer involved in any political activity, though he had previously been active in the Kurdistan Democratic Party (KDP), one of the main Kurdish organizations and controls part of Iraqi Kurdistan.

BACKGROUND INFORMATION

Hundreds of political detainees belonging to unauthorized political groups are currently held in Syrian prisons, some serving sentences of up to 22 years handed down by the Syrian Supreme State Security Court after grossly unfair trials. Torture and ill-treatment of detainees, especially during the interrogation stage, is routine. Amnesty International has a list of detainees who have died in custody reportedly as a result of torture and/or grossly inadequate medical care.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English, Arabic, French or your own language:

- expressing concern at the incommunicado detention of 'Abdallah Ahmad Muhammad and calling for his immediate release unless he is charged with a recognizably criminal offence;
- urging that he be allowed immediate access to adequate medical care and the medication he needs, and to his family and a lawyer;
- -seeking assurances that 'Abdallah Ahmad Muhammad is being humanely treated and not tortured or ill-treated.
