Amnesty International deeply regrets the execution by hanging of five people on 9 October 1991. Three of those executed, Mustapha Benhassine, Mohammed Nighaoui and Mohammed Fathi Zribi, were suspected sympathizers of the illegal Islamic movement al-Nahda (Renaissance). They had been accused of murder and arson committed against the headquarters of the ruling party in the Bab Souika district of Tunis in February 1991. The other two, Ali Daggachi and Abdelkarim Horchani, were accused of murder and rape.

In May 1991 the Criminal Court sentenced Mustapha Benhassine to 20 years' imprisonment and Mohammed Nighaoui and Mohammed Fathi Zribi to life imprisonment. However, on 25 June 1991, the Court of Appeal changed their sentences to the death penalty.

Ali Daggachi was sentenced to death for rape and murder by the Criminal Court in Gafsa on 6 November 1989. The sentence was upheld by the Court of Cassation on 5 December 1989. Abdelkarim Horchani was also apparently sentenced to death for rape and murder.

The announcement on 9 October that President Ben Ali had signed the death warrants was made at the same time as that of the executions. The President was said at the same time to have commuted five other death sentences, including the death sentence on Lamari Dali (see UA 519/90, MDE 30/07/90, 30 December 1990, and follow-up, MDE 30/06/90, 28 December 1990). Imed Mghirbi and Mongi Ra'ash, whose 20-year sentences were raised to death sentences in absentia by the Court of Appeal, are still believed to be in hiding.

In March 1988 President Ben Ali told Amnesty International delegates that he was personally opposed to the death penalty and would not sign any death warrant. In November 1989 the President announced, in a speech marking his second anniversary as head of state, that he had suspended the death penalty. However, a man was executed in November 1990 after having been sentenced to death in May for multiple murder and rape.

FURTHER RECOMMENDED ACTION: Telegrams/telexes/express letters/airmail letters, in FRENCH if possible:

- expressing deep regret at the execution of Mustapha Benhassine, Mohammed Nighaoui, Mohammed Fathi Zribi, Ali Daggachi and Abdelkarim Horchani;
- reiterating concerns that three of those executed were originally

sentenced to lower sentences by the Criminal Court;

- expressing regret that the President has rejected appeals for clemency after having stated his personal opposition to the death penalty;
- urging that all remaining death sentences be commuted and that Tunisia take the necessary measures to work towards the abolition of the death penalty.
