Concern is mounting for the Tunisian prisoners on hunger strike, some of whom have not eaten for up to 64 days and are suffering severe health problems.

Fathi Kararoud, who has been on hunger strike since 3 September, was unable to walk and could hardly speak when he appeared in court on 27 October.

Abdallah Drissa, who has not eaten since 4 September, was hospitalised for one day on 24 October. When his family tried to visit him in prison on 27 October, they were refused access. They were told that his blood pressure had fallen below 8, and his pulse below 40.

Abdelatif Bouhajila's family were refused permission to visit him in prison on 24 October. Three days later, his lawyer was prevented from seeing him, even though she had a valid visiting permit issued by the competent judiciary authorities. He has been on hunger strike since 28 August and is apparently confined to a wheel chair. He has reportedly been ill-treated while on hunger strike.

The families of other prisoners on hunger strike, including Yacine Ben Zarti and Maher Khalsi, have also been refused permission to visit. Other detainees continue to join in the hunger strike, including Lotfi Ferhati, who began his hunger strike at the beginning of October.

On 28 October at least seven female relatives of the prisoners were arrested as they sought to raise the issue with the general assembly of the Tunisian Human Rights League (LTDH). They were taken to a nearby police station, where they were interrogated and made to sign interrogation records before being released.

At the end of its general assembly on 29 October, the LTDH called on the authorities to release the prisoners as a matter of priority, and to declare a general amnesty for the about 1000 prisoners of conscience detained in Tunisian prisons.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Arabic, French or in your own language:

expressing concern about the health of the prisoners on hunger strike, calling for them to be kept under medical surveillance, to be given appropriate medical care, and to be granted prompt and regular access to their families and lawyers;
calling for all prisoners on hunger strike to be treated humanely, urging that they are not subjected to beatings, ill-treatment and other cruel, inhuman or degrading treatment.
