**AUSTRIA: ALLEGATIONS OF CRUEL, INHUMAN AND DEGRADING TREATMENT BY POLICE AND PRISON-OFFICERS**

**Austrian police and prison-officers are subjecting foreigners, including asylum-seekers, to cruel, inhuman and degrading treatment or punishment Amnesty International said in a report published this week.**

**The report documents a number of allegations of ill-treatment, including several cases where it has taken place while the foreigners in question were being held in administrative detention pending deportation.**

**In June 1993 two delegates attending the World Conference on Human Rights in Vienna saw police officers kick and hit an Algerian man at Vienna Schwechat airport during an attempt to deport him following rejection of his asylum application. The delegates complained to an airport official but were told "This is not your problem". When they protested further, they were told that the man was being beaten because he was a "criminal", an "Algerian" and a "prisoner". Although the delegates made a formal complaint to the Federal Ministry of the Interior, the government replied that no ill-treatment had occurred.**

**In March 1993 a police officer refused to allow detainee Dickson Nosa Oviawe to finish dressing before seeing an Amnesty International refugee advisor. The 30 year-old Nigerian, who had been arrested and placed in administrative detention in Vienna pending deportation, had to conduct an interview about his possible deportation dressed only in his shirt.**

**Although at first extremely anxious about making a formal complaint about his humiliating treatment, Dickson Nosa Oviawe eventually did so through his lawyer. The Federal Ministry of the Interior responded that it had not been possible to identify the officer involved in the incident. They also claimed that "when officers check the detainee's clothing they look only at what he is wearing above the waist, not below".**

**"Asylum-seekers in particular, are often reluctant to make any formal complaint if they are ill-treated, for fear that this might prejudice their asylum claim", Amnesty International said. Many asylum-seekers also face considerable difficulties in contacting relatives, legal representatives or human rights organizations while they are in pre-expulsion detention (Schubhaft). Amnesty International fears these two factors could mean that the actual number of cases of ill-treatment is much higher than that reported.**

**HONDURAS: AMNESTY INTERNATIONAL VISIT**

An Amnesty International delegation in Honduras from 25 May to 3 June, will be meeting with members of the government, which took office earlier this year, and will be gathering information on alleged human rights violations in the country.

At the meetings, the three delegates -- all Amnesty International staff members -- will raise the organization's concerns on possible extrajudicial executions, disappearances, torture and ill-treatment during previous administrations; as well as the continued impunity surrounding past human rights violations to members of the government. The delegates will also seek information on the progress of a number of human rights reforms initiated since 1993.

**\*\* NO PUBLICAR HASTA EL 30 DE MAYO DE 1994 \*\***

**AMNISTÍA INTERNACIONAL VISITA HONDURAS**

Una delegación de Amnistía Internacional visitará Honduras del 25 de mayo al 3 de junio. Los tres delegados -- todos ellos funcionarios de la organización --, se entrevistarán con representantes del nuevo gobierno y recabarán información sobre presuntas violaciones de derechos humanos.

En el curso de las entrevistas, los delegados discutirán casos de posibles ejecuciones extrajudiciales, desapariciones forzadas, tortura y malos tratos que preocupan a Amnistía Internacional y que ocurrieron durante gobiernos anteriores; también discutirán la continua impunidad que rodea las pasadas violaciones de derechos humanos. Los delegados recabarán asimismo información sobre el progreso de ciertas reformas introducidas en materia de derechos humanos desde 1993.
