





Victims of reported disappearances and alleged extrajudicial and unlawful killings in Balochistan, 24 October 2010 - 20 February 2011


The information presented below is based on reports that Amnesty International has received from Baloch civil society groups and credible media reports, since our latest press release of 26 October 2010, highlighting the issue of murder and torture of Baloch activists. Amnesty International has not been able to corroborate the details of each incident. However, we look to the Pakistan government to conduct credible, impartial and transparent investigation into each allegation.

The emerging trends of alleged human rights violations in Balochistan are disturbing. As demonstrated by the below graphs, the reported disappearances and killings of Baloch activists in the recent months have increased. People who previously were reported missing were later found killed and their bodies allegedly bore marks of torture.





During the period Oct 2010 – Feb 2011, 65% of the total number of cases of people who were allegedly disappeared were later found killed and their bodies dumped.
