Death penalty

Malaysia. A government programme demonstrating punishment floggings to schoolchildren has been suspended after it drew public criticism. The government is considering introducing public flogging before execution as a punishment for child rape, after the rape and murder of two 10-year-old girls in the space of a week earlier this year. USA. The US Supreme Court has ruled that a death row inmate can pursue an appeal on the grounds that lethal injection would be cruel and unusual punishment. David Larry Nelson says his veins - damaged by drug use - make it impossible to inject him without cutting deep into his flesh and muscle. USA. Laurence Adams, who was sentenced to death in Massachusetts in 1974 shortly before the state finally abandoned capital punishment, was released on May 20 after spending three decades of his life in prison. USA. Texas Governor Rick Perry has issued a pardon on the basis of innocence to Josiah Sutton, a juvenile offender who had served four years of a 25-year prison term before new DNA tests proved his innocence. The faulty DNA results used to convict Sutton in 1998 were processed by the now thoroughly discredited Houston Police Department crime lab, the same facility that processed DNA and other forensic evidence used in cases that have resulted in death sentences. USA. Gordon Randall Steidl was released from prison in Illinois on 28 May after being wrongly convicted and spending 17 years in prison, including twelve years on death row.

Torture

Croatia. Sexual torture of men in wartime Croatia was regular and substantial. Evidence of rape and other forced sexual acts, castration, genital beatings and electric shock is documented in new research funded by Médecins Sans Frontières. Human Rights Watch (HRW) acknowledged its error in attributing the cause of the death of a man in police custody to torture after a team of international experts found that the man, Andrei Shelkavenko, died as a result of hanging. HRW also urged the Uzbek government to continue its inquiry into the circumstances of the man's death and allegations that he had been beaten in custody and his relatives harassed. Jordan. A Jordanian man has reportedly shot his unmarried cousin dead as she recovered in hospital after delivering a baby.
